Cats: * Rabies, Feline Distemper (FVRACP), and feline Leukemia (if frequent outside)

FLEA PREVENTATIVE: is **required for both dogs and cats and it will be documented at each visit. Please consult with your veterinarian to find out which flea preventative is right for your pet(s).**

BELONGINGS: We supply raised beds and bowls. **PLEASE BRING: Food. We request belongings be limited to 5 items or less. Any bedding must be clean. Please limit size, so it can be easily laundered if soiled. Additional charges may apply.**

1. **The client upon services rendered shall pay for any additional necessary costs such as food, supplies, bathing, or vet fees.** We give Funny Farm Petcare permission to obtain pet(s) vaccination records, take our pet(s) to the veterinarian or contact the veterinarian as necessary.

In case of life threatening pet emergency, please choose the level of veterinary services you would like us to provide:

A trip charge will be assessed, along with medication costs or any other necessary fees incurred from the appointment. Additional fees may apply if the appointment is scheduled with a vet outside the local area. **Funny Farm Petcare also reserves the right to bathe any pet that becomes soiled during the pet's stay. Additional charges may apply.**

2. If a client knowingly or intentionally brings a pet with a **contagious infection, parasite, or disease** or a **"dangerous or vicious pet(s)"**, the client is **fully** liable for any and all damages including but not limited to hospital fees, damages, decontamination and court costs. **Pets must be friendly enough for our staff to handle.** (Allow us to put on leash, come in and out of suites, etc.)
3. **Funny Farm Petcare and its employees agree to provide the services stated in this contract in a reliable and trustworthy manner.** In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims not limited to verbal, or in writing against Funny Farm Petcare and its employees, unless arising from negligence.
4. Funny Farm Petcare is **not responsible** for any **damaged or lost items** and **ALL PETS MUST BE RESTRAINED ON A LEASH OR IN A CARRIER** while entering and exiting our facilities.
5. The client fully understands the contents of this contract, and by signing below **takes full responsibility for payment** of all reasonable and customary charges **upon services rendered.** All costs of collection as a result of non-payment including attorney fees shall be paid by the customer. **A late charge may be added if payment is not received within 5 days of services rendered or for any returned checks.**
6. **Pick-ups and Drop-offs are during our set office hours.** Missed appointments without prior notice, may incur an additional charge. **CLIENTS WILL BE CHARGED YOUR FULL RESERVATION DURING ANY SCHOOL BREAKS, HOLIDAYS, JUNE, JULY, INCLUDING EARLY PICK UPS. Anything outside of set office hours may also incur additional charges.**
